#### How does health coaching work?

You can participate in a complimentary health coaching program if you have a premium loading on your new OneCare policy due to a recent assessment of increased health risks, due to your Body Mass Index (your height /weight index) and either elevated levels of cholesterol and/or blood pressure. Conducted over an eight month period of phone consultations, an experienced coach from Remedy Healthcare will work with you to address and improve these health risks.

At the end of your health coaching program, you will be requested by your health coach to visit your local medical centre or your General Practitioner (GP) for a reassessment on your Body Mass Index, cholesterol and blood pressure (as applicable). OnePath will reduce your premium loadings upon receiving confirmation that you have achieved the health improvement outcomes outlined in your health coaching application form.

Remedy Healthcare health coaches are qualified healthcare professionals, such as dieticians, who have additional training in supporting healthy lifestyle change. Programs are designed to be highly personalised, convenient and motivational.

#### What will the health coaching cover?

Your health coach will work with you to create a personalised health plan based on your lifestyle and schedule. Your health plan will be designed to improve your confidence, health knowledge and awareness of how to manage your health. Not only do the health coaches empower you to take control of your health, they also stick with you, giving you the tools you need to achieve success.

#### How much time will it take?

Remedy Healthcare will schedule 30 minute telephone appointments every three to four weeks when it is convenient for you. However, as this is a tailored program, appointments can be adapted to your needs. Once enrolled, your health coaching program will run for eight months, beginning from your first appointment with your health coach.

#### Do I have to do health coaching?

### Can I reduce my insurance premium loading regardless of completing the health coaching program?

However, it is helpful to complete the health coaching program to ensure you're on track for long-term improved health. Completing this program and achieving the required health improvement goals in your health coaching application form, provides access to an immediate reduction to your OneCare insurance premium loading, without the need for another underwriting assessment.

## Should I consult my GP prior to participating in the program?

We recommend you consult your GP or an appropriate healthcare provider before you begin any exercise, health or wellbeing program. The program aims to complement your existing health services, providing additional support and motivation. Many individuals participate in the program alongside attending appointments with their doctor, dietician, physiotherapist or rehabilitation program.

#### Is my personal health information confidential?

OnePath will only provide Remedy Healthcare with information contained on your health coaching application form. This will help Remedy Healthcare understand your initial health status. All the information you provide to Remedy Healthcare is kept in strict confidence.
